**Young Hearts Intergenerational Programme:** is a collaborative education initiative between Croí na Gaillimhe and Our Lady's College, Presentation Road, Galway City, involving schools, teenagers and older adults, working together within a community learning environment. It encourages, supports and accommodates active experiential learning among participants of the programme, thus eliciting specific learning outcomes from the curricular based objectives of the programme.

The activities: Creative Writing leading to production of books, presentation and development of many drama pieces, art modules leading to art exhibitions, enterprise project - making crafts for craft fairs, carol singing, occasional outings and participation in Astronomy project with NUI Galway.

The written risk assessment indicates the areas of potential harm, the likelihood of harm occurring, and lists the required policy, guidance, process and practice required to alleviate the risks.

Risks are identified in the following categories:

- Trips \Excursions
- Recruitment and Selection
- Technology and Social Media and photography

In addition to this service/activity risk assessments the following procedures are in place throughout SVP as part of our safeguarding policies and procedures:

- Procedures for managing allegations of abuse or misconduct by volunteers or employees against a child availing of our services.
- Procedures for the safe recruitment of volunteers or employees to work with children in our services.
- Procedures to access child safeguarding training, including the identification and reporting of harm.
- Procedures for reporting child protection and welfare concerns to Statutory Authorities.

SVP Croí na Gaillimhe – Young Hearts Intergenerational Programme recognises that implementation is an ongoing process – we are committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm.
