- Procedure for maintaining a list of persons in the relevant services who are mandated persons.
- Procedures for appointing a relevant person for the purposes of the Statement.

SVP and Ozanam House Resource Centre, Dublin 1 recognise that implementation is an ongoing process and we are committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm.
